TENDER NOTICE AND INVITATION TO TENDER

The Ubuntu Local Municipality hereby invites tenders in terms of Section 83 of the Municipal Systems Act, Act 32 of 2000 (as amended) and Sections 110 and 112 of the Municipal Finance Management Act, Act 56 of 2003, for civil engineering contractors service providers for various municipal infrastructure projects for a period of 3 years (36 months) as and when required.

Only those tenderers who are actively registered with the CIDB with a contractor grading designation equal to or higher than the latest CIDB promulgated contractor grading designation of 5CE PE or 6CE. Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data are eligible to submit tenders. Tenderers must be registered on the CSD.

The Ubuntu local Municipality Procurement and Supply Chain Management Policies, the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and Preferential Procurement Regulation, 2022 and bidders may claim preference in terms of specific goals.80 for price and 20 for specific goal .

Forms MBD4, 8, 9 to be fully completed and attached. Proof that no monies are owed to any municipality by the company and any of its directors must be attached i.e. municipal accounts. Tender documents need to clearly flagged and referenced.

Tender documents shall be available at Ubuntu Local Municipality website or on the e-tender website downloadable for free form 16 October 2024.

Tender documents are to be completed in black ink and in accordance with the conditions and rules contained in the bid documents and must be placed in a sealed envelope and clearly marked.

The completed Tender documents must be placed in the Tender Box, situated at the main reception area of Ubuntu Local Municipality, 78 Church Street, Victoria West, 7070, no later than 14 November 2024 at 12h00.

Telephonic, facsimile, email and/or late bids will not be accepted. Bids must be valid for a period of ninety (90) days after the closing date of the bid.

Ubuntu Local Municipality does not bind its self to accept the lowest bid or to award a contract to the bidder scoring the highest number of points.
